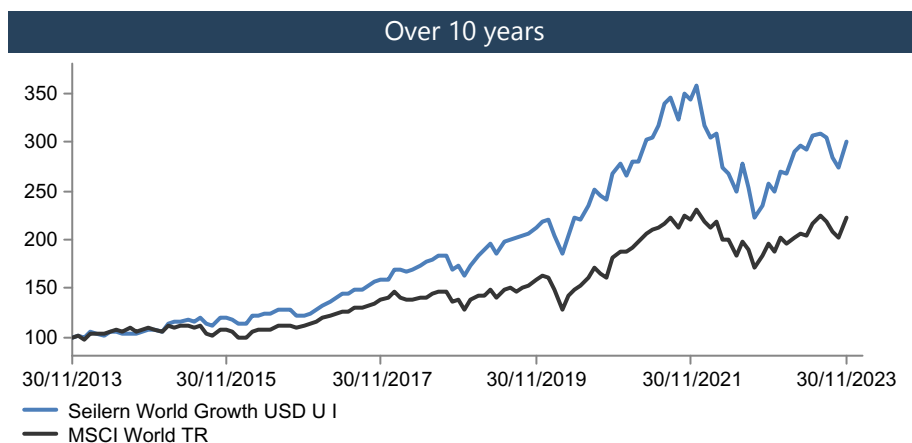
Commentary

Idexx was the best performer this month, up +16.6%. The company posted solid results at the start of the month and the stock was also helped by the move lower in interest rates. Adobe was the second-best performer, up +14.8%. There was no company-specific news, though some broker notes highlighted its strong position in generative AI. Veeva was the worst performer, down -9.6%. At the annual investor day management tweaked down guidance for next year due to a worsening macro environment that we have seen elsewhere in life sciences. An undisclosed position was the second-worst performer, down -0.5%. While there was no company-specific news, the perceived regulatory uncertainty in the French market may have dampened investor sentiment.

Definitions:

The Seilern World Growth USD U I fund is actively managed and uses the MSCI World TR as the benchmark index against which the Fund's performance is compared. "TR" stands for total return, and it assumes any cash distributions, including dividends are reinvested. "CAGR" stands for the compound annual growth rate.
