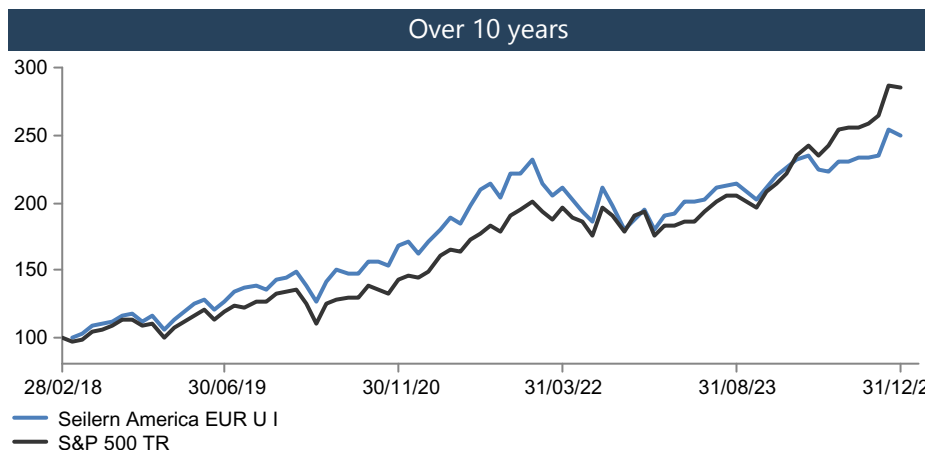
## Commentary

Alphabet was the best performer this month, up +12.04%. The company's announcement of a breakthrough in quantum computing raised investors' confidence in its ability to drive future innovation. Edwards Lifesciences was second best, up +3.76%. The company held an investor day where the company set 2025 guidance ahead of expectations and reconfirmed their medium-term guidance for 10% sales growth. UnitedHealth was the worst performer, down -17.10%. The tragic death of the CEO of UnitedHealthcare (UnitedHealth's subsidiary) triggered a PR crisis. Proposed Pharmacy Benefit Manager (PBM) reforms further negatively impacted market sentiment. Adobe was second worst, down -13.81%. The company issued guidance for 2025 at their full year results which was below expectations and, having rallied 15% into these results, the stock sold off.
