Investment Objective

The fund seeks to achieve growth of your investment by investing mainly in shares (equity) and similar securities issued by high quality companies listed on the stock exchanges of countries within the Organisation for Economic Cooperation and Development (OECD) and, in particular, the U.S. and North American OECD countries.

Commentary

Adobe was the best performer, rising +24.91%. Second quarter results were ahead of consensus and the company raised guidance for the full-year, bucking the trend of other software companies' results and alleviating concerns of competitive threats from AI. Microsoft was second best, up +7.67%. There was no news, but market excitement around the company's AI-driven prospects continue to underpin its share price strength this year. Nike was the worst performer, down -20.70%. The company's quarterly results were overshadowed by a negative guidance revision for Fiscal 2025 that will see the business shrink by mid-single digits. The revision highlighted weakness in China and accelerated stock reductions in developed markets. Visa was second worst, falling -3.67%. The stock price weakened on the news that a federal judge rejected the \$30 billion settlement announced in March between Visa, Mastercard and US merchants to cap credit-card fees.
