
Commentary

CME was the best performer, up +7.29%. The company posted results that beat across the board, from transaction and clearing fee revenue to market data and information services. Visa was second best, up +6.30%. Strong first quarter results, a raised FY25 guidance and an investor day in February reassured investors on the durability of its growth drivers. West Pharmaceutical was the worst performer, down -31.93%. At their full-year results, the company announced lower growth expectations, the exit of its glucose monitoring device business due to unattractive economics, investment into lower-margin business segments and enduring destocking challenges. Alphabet was second worst, down -16.54%. Despite strong fourth quarter advertising growth in Search and YouTube, slowing cloud growth and higher projected capex for 2025 dampened investor sentiment.
