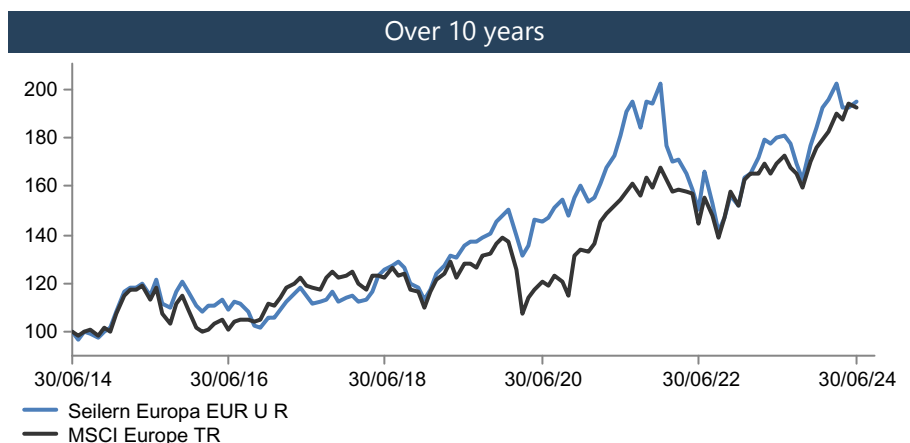
Commentary

SAP was the best performer, rising +14.20%. While there were no major changes to their strategy at their Capital Markets Day, against a broader backdrop of weakness in the sector the reaffirmation of guidance was well-received. Novo Nordisk was second best up +8.44%. The stock reacted positively to the announcement of incremental manufacturing capacity in the US as well as to the approval of Wegovy for the treatment of Obesity in China. L'Oreal was the worst performer, falling -9.30%. The CEO lowered the growth outlook for the global beauty market from "above 5%" to "4.5 to 5%", citing weakness in China and a slight slowdown in the US. Edenred was second worst, falling -8.46%. While there was no company-specific news during the month, the French snap election likely increased market uncertainty and dampened investor confidence in companies like Edenred.

Definitions:

The Seilern Europa EUR U R fund is actively managed and uses the MSCI Europe TR as the benchmark index against which the Fund's performance is compared'. "TR" stands for total return, and it assumes any cash distributions, including dividends are reinvested. "CAGR" stands for the compound annual growth rate.
