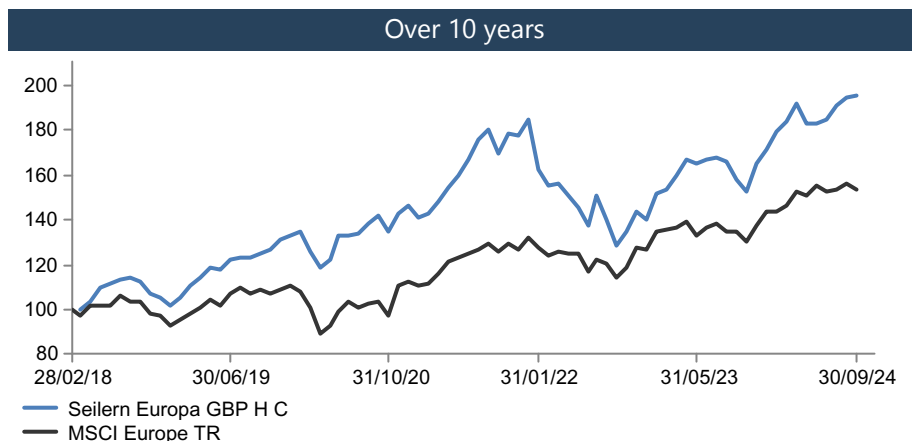
## Commentary

Rightmove was the best performer, up +11.1% for the month after an acquisition offer by REA Group, an Australian digital advertising business specialising in property and best known as the owner of the Australia's leading real estate portal. Straumann was second best, rising +10.20% after releasing better than expected second quarter results in August and announcing the sale of Dr Smile, its direct-to-consumer clear-aligner business. Novo Nordisk was the worst performer down -16.13%. The stock reacted negatively to the prospect of increasing competition in the obesity space and the potential for greater than anticipated pricing pressure as a result. Edenred was second worst, down -10.97%. The stock was weighed down by several macro headwinds: a French fiscal budget crisis, a slowdown in the French economy and consequent uncertainty regarding new meal vouchers regulation.

### Definitions:

The Seilern Europa GBP H C fund is actively managed and uses the MSCI Europe TR as the benchmark index against which the Fund's performance is compared. "TR" stands for total return, and it assumes any cash distributions, including dividends are reinvested. "CAGR" stands for the compound annual growth rate.
