Investment Objective

The fund seeks to achieve growth of your investment by investing mainly in shares (equity) and similar securities issued by high quality companies listed on the stock exchanges of countries within the Organisation for Economic Cooperation and Development (OECD) and, in particular, the U.S. and Western European OECD countries.

Commentary

Novo Nordisk was the best performer up +6.13%. Reassuring guidance for 2025 at their FY24 results, as well as granular data on their future obesity portfolio given during an investor event, helped the stock. Mastercard was second best, up +3.76%. Solid fourth quarter results at the end of January and guidance ahead of expectations helped the stock. West Pharmaceutical was the worst performer, down -31.93%. At their full-year results, the company announced lower growth expectations, the exit of its glucose monitoring device business due to unattractive economics, investment into lower-margin business segments and enduring destocking challenges. Alphabet was second worst, down -16.54%. Despite strong fourth quarter advertising growth in Search and YouTube, slowing cloud growth and higher projected capex for 2025 dampened investor sentiment.
