Investment Objective

The fund seeks to achieve growth of your investment by investing mainly in shares (equity) and similar securities issued by high quality companies listed on the stock exchanges of countries within the Organisation for Economic Cooperation and Development (OECD) and, in particular, the U.S. and Western European OECD countries.

Commentary

Hermès was the best performer this month, up +12.45%. The company continued to exhibit superior resilience over peers and the stock reflected expectations for greater consumer appetite in the year ahead. Alphabet was the second-best performer, up +12.04%. The company's announcement of a breakthrough in quantum computing raised investors' confidence in its ability to drive future innovation. Novo Nordisk was the worst performer, down -17.58%. The company published the results of its REDEFINE 1 trial for its drug for the treatment of obesity, CagriSema. The trial demonstrated weight loss of 22.7% which was below market expectations of more than 25%. UnitedHealth was second worst, down -17.10%. The tragic death of the CEO of UnitedHealthcare (UnitedHealth's subsidiary) triggered a PR crisis. Proposed Pharmacy Benefit Manager (PBM) reforms further negatively impacted market
